3 - EVALUATION AND ASSESSMENT

The Personal Protective Equipment/s being the subject of this EC Type Examination Certificate fall/s under the field of application of Art. 8 comma 4.a of European Directive 89/686/EEC, concerning devices of complex design. Such classification corresponds within the Italian legislation to the Category III.

In consideration of the technical documentation supplied by the Manufacturer, the annexed test Reports n° PPE086RP1900, n° PPE086RP1901, n° PPE/RP 1529-09, n° PPE/RP 733-03 and n° PPE/RP 624-02 which detail the results of the additional tests carried out in accordance with the reference standards, the PPE listed above meets the basic health and safety requirements as specified by the Directive 89/686/EEC, Art. 3 and Annex II.

Particular informations: The evaluation of the basic health and safety requirements set out in Annex II of E.D. 89/686/EEC for the model "FUGE TAIL" is limited to the evaluation of the technical performances of the self-contained air breathing apparatus for escape when used as "back-up" device with compressed air line breathing apparatus. It is therefore excluded by this Document the evaluation of complete conformity to the standard EN 14593-1 april 2005 for all the requirements not appropriate with the "back-up" function.

NOTES:

- The "User Information" was approved only in the Italian version and as far as the PPE under test was concerned;
- the complete descriptions of the PPE object of the present Certificate (drawings included when applicable) are available near ITALCERT;
- the Personal Protective Equipment manufactured shall be subject, of one of the two procedures according to the Manufacturer's choice, to one of the two procedures referred to in Article 11 (Article 11.A - EC quality control system for the final product or Article 11.B - System for ensuring EC quality of production by means of monitoring) with a notified Body chosen by the Manufacturer.
