LIMITATIONS OF USE

Do not use in environments with oxygen concentrations below 19,5% (refer to local regulations for further indications) and in presence of gases and/or vapors. Choice of filter depends on the kind of contaminant, its TLV and concentration in the workplace, the filter capacity and the inward leakage (TIL) of the facepiece used. The filter has passed the tests of the EN 143:2021 standard, so it is **reusable**.

Store at temperatures between -5°C and +35°C with a maximum relative humidity of 75%.

Maximum height with thread: 24 mm approx.

PACKAGING

Each filter is supplied individually wrapped in a transparent plastic bag in a carton box of 10 units.

EXPIRY DATE

The filter, properly preserved in its original packaging, expires 10 years from its production date indicated on the packaging. This date is indicated on the filter label and on its packaging.
